#### CHRIS BAUMAN, PHD

Associate Professor of Organization and Management, Faculty Director, Masters of Innovation and Entrepreneurship

Chris Bauman's research addresses how people make sense of and respond to their social environment, including the individuals, groups, and organizations with whom they interact. One line of his research focuses on how individuals determine issues of ethics and fairness. This work includes studies of individual decision making, group diversity, and corporate social responsibility. Another line of his research examines information processing in negotiation and its implications for tactics that can increase individual or mutual gains.

His research has been published in top academic journals, including Academy of Management Journal, Journal of Personality and Social Psychology, and Organizational Behavior and Human Decision Processes. His work has also been featured in The Wall Street Journal, The Atlantic, the Boston Globe, and the Orange County Register.

Chris Bauman earned his Bachelor of Science degree at the University of Wisconsin-Madison and Master of Science and PhD degrees at the University of Illinois at Chicago. He was previously a member of the faculty at the Foster School of Business at the University of Washington. He also was a post-doctoral fellow at the Dispute Resolution Research Center at Northwestern University.
